**F. EXECUTIVE SESSION**

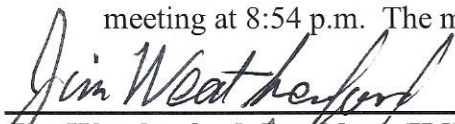
1. Jim Weatherford call the meeting into Executive Session pursuant to the Texas Open Meeting Act Section: 551.0754at 7:23 pm.
