**CALL TO ORDER**

5. Discussion was held regarding request from taxpayer to refund penalty and interest accrued on a tax payment, citing Section 33.011(h) of the Texas Property Tax Code. A motion was made by Jim Hollis and seconded by Bert Bronaugh to approve refunding the penalty and interest. The motion passed unanimously. (4-0)

7. No Commissioner reports were presented. No action required.
8. The 5 Year Plan was discussed. No action required.
