**D. ACTION ITEMS**

1. Discussion was held on the minutes for the meeting on June 20, 2018. A motion was made by Scott Stevens and seconded by Carol Greaves to accept the minutes as presented. The motion passed unanimously. (5-0)

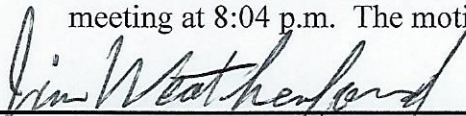

Discussion was held on amending the budget for fiscal year ending September 30, 2018 to allow the Training Tower Note to be paid in full, adjusting the Debt Principal Expense amount and the Debt Interest Expense. A motion was made by Scott Stevens and seconded by Carol Greaves to amend the Debt Interest for \$21099.53 and Debt Principle for \$295,497.33. The motion passed unanimously. (5-0)
7. Discussion was held on proposing the tax rate for 2019 at \$0.10 cents per \$100 taxable valuation, setting Public Hearing dates for the proposed tax rate. A motion was made by Scott Stevens and seconded by Paul Kaskie to propose the 2019 tax rate at \$0.10 cents per \$100 taxable valuation and schedule the Public Hearings for August 22, 2018 at 7:00 p.m., August 29, 2018 at 7:00 p.m. and adopt budget and set the tax rate on September 12, 2018 at 7:00 p.m. The motion passed with Jim Weatherford in favor, Scott Stevens in favor, Joe Segovia in favor, Paul Kaskie in favor and Carol Greaves in favor. 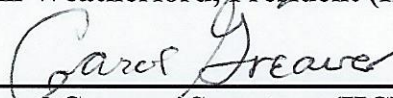
**E. STAFF REPORTS**
